#### **MINUTES**

# ORDINANCE 25-21: SETTING THE SALARIES AND HOURLY WAGES FOR EMPLOYEES OF THE CIVIL CITY OF FRANKFORT, INDIANA

# ORDINANCE 25-22: SETTING THE SALARIES AND HOURLY WAGES FOR ELECTED OFFICIALS OF THE CIVIL CITY OF FRANKFORT, INDIANA

Councilmember Beardsley made a motion to read Ordinance 25-22 by title only, seconded by Councilmember Warthan. Upon a roll call vote, seven ayes were recorded. Motion carried 7-0.

City Clerk Treasurer Carol Bartley read ordinance 25-22.

Councilmember Warthan made a motion to approve ordinance 25-22 on first reading, seconded by Councilmember Stevens. Upon a roll call vote, seven ayes were recorded. Motion carried 7-0.

### ORDINANCE 25-23: ADDITIONAL APPROPRATION

Councilmember Woods made a motion to read Ordinance 25-23 by title only, seconded by Councilmember Beardsley. Upon a roll call vote, seven ayes were recorded. Motion carried 7-0.

City Clerk Treasurer Carol Bartley read ordinance 25-23.

This ordinance is for an additional appropriation for the Street Department. Jake Miller with the Street Department explained to the Council that the department has a 2009 loader that needs significant repairs. The repairs would take several months, cost \$65,000.00 and the engine would be shipped to Belgium for the repair. A 2019 replacement loader purchase cost would be \$132,050.00. The department is recommending the purchase of a 2019 CAT loader to replace the unit. Councilmember Beardsley made a motion to approve Ordinance 25-23 for the amount \$132,050 to purchase the 2019 loader on first reading, seconded by Councilmember Warthan. Upon a roll call vote, seven ayes were recorded. Motion carried 7-0.

# RESOLUTION 25-07: A RESOLUTION DIRECTING TRANSFER OF APPROPRIATED FUNDS

City Clerk Treasurer Carol Bartley informed the board that there was a payroll mistake for a former Street Dept. employee who transferred to the utilities. The overtime pay was paid incorrectly from an MVH appropriation. State Board of Accounts recommend we do a transfer from the correct utility fund to replace the funds in the MVH appropriation. Councilmember Warthan made a motion to approve Resolution 25-07, seconded by Councilmember Stevens. Upon a roll call vote, seven ayes were recorded. Motion carried 7-0.

## **NEW BUSINESS**

Susan Kaspar presented the board with statistical data regarding The Crossing School. She requested a donation to sponsor the annual school banquet. Councilmember Woods made a motion to approve \$3000 from unrestricted opioid funds to sponsor The Crossing Banquet, seconded by Councilmember Stevens. Upon a roll call vote, seven ayes were recorded. Motion carried 7-0.

#### **ADJOURNMENT**

There being no further business to come before the Council, Councilmember Stevens moved to adjourn, seconded by Councilmember Beardsley. Mayor Sheets adjourned the meeting at 7:34 PM.
