## **Board of Zoning Appeals**

August 20, 2025

The City of Frankfort Board of Zoning Appeals met at a Regular Meeting on August 20, 2025, in the City Council Chambers, 301 E. Clinton St., Frankfort, IN, at 5:00 PM.
