

INVITATION TO BID

Notice is given that the City of Frankfort, Indiana, acting through its Board of Public Works and Safety, will receive sealed written bids at the Office of the Clerk-Treasurer, 301 S. Clinton Street, Frankfort, Indiana 46041, until the hour of 4:00 P.M., local time, on the 14th day of August 2023, for the following:

Dorner Park Pickleball Courts Asphalt Reconstruction Project

Bids will be opened and read aloud at the regular meeting of the Board of Public Works and Safety of the City of Frankfort, Indiana, meeting at 5:00 p.m. local time on August 14, 2023, in the Council Chambers at 301 E. Clinton Street, Frankfort, Indiana.

The contractor will be expected to remove dirt and install asphalt for four pickleball courts, with an area of approximate sixteen thousand five hundred feet (16,500) square feet. The contractor is expected to excavate, and dispose of properly, all existing asphalt. Additionally, the contractor will be expected to grade and prepare existing stone base to proper elevations and compact with a vibratory roller. The contractor is also expected to remove approximately twelve (12) inches of dirt from the area, install eight (8) inches of stone base to approximately six thousand five hundred (6,500) square feet, furnish and install two and a half (2.5) inches (compacted thickness) of twenty-five (25) millimeters asphalt base and compact with vibratory roller, furnish and install one and a half (1.5) inches compacted thickness of nine and a half (9.5) millimeters asphalt surface and compact with vibratory roller, and finish roll and barricade lot of the pickleball courts.

The bid must provide a breakdown of materials and labor for the asphalt reconstruction, as well as a total for the entire project.

Each bid shall include an executed Contractor's Bid for Public Work-Form 96 as prescribed by the State Board of Accounts, accompanied by a Non-Collusion Affidavit and a certified check made payable to the City of Frankfort, Indiana, or an approved Bid Bond in the amount of ten percent (10%) of the bid. The contract to be entered into with the successful bidder will require the contractor to comply with the employment eligibility requirements of Indiana Code § 22-5-1.7, the contractor requirements of Indiana Code § 5-16-13 and the Iran certification requirements of Indiana Code § 5-22-16.5.

The Board of Public Works and Safety of the City of Frankfort, Indiana, reserves the right to reject any or all bids, or to accept the one in its judgment to be the lowest, most responsive, most responsible, and in the best interests of the City of Frankfort, Indiana.
